# FAQ

**Q: Do I have to personally purchase 100 BV to qualify for this promotion?**

**A:** While personal purchases totaling 100 BV for the month will qualify you for this promotion, retail orders from your replicated Isagenix website can also be used to qualify you. Additionally, a combination of both can be used.

**Q: What is the commission month schedule?**

**A:** Leadership Pool calendar for 2020 will be here

**Q: How long of a grace period do I get if one or more of my personally enrolled Consultants isn't Paid-As Consultant in the commission month?**

**A:** We currently give a one-day grace period to get back to having the necessary number of Paid-As Consultants

**Q: Where can I go to see the number of personally enrolled Paid-As Consultants each day?**

**A:** TBD

**Q: Do I earn the US\$1,000 bonus after any three months, as long as they are consecutive?**

**A:** Yes. After any three consecutive months, you will earn the US\$1,000 bonus

**Q: Will I earn the US\$1,000 bonus after three cumulative months of qualifying?**

**A:** No. The three months must be consecutive to earn the US\$1,000

**Q: When are the bonuses paid?**

**A:** Earned bonuses are paid in the following month on the Monday closest to the 15th

**Q: Which markets are participating in this promotion?**

**A:** All markets outside of Korea are participating in the Executive Lifestyle Bonus promotion

**Q: Do I need to be on Autoship to earn this new bonus?**

**A:** No. This is not one of the requirements to earn this new bonus.

**Q: What does it mean to be Paid-As Executive for each day of the commission month?**

**A:** Each day, have ten (10) or more personally enrolled Paid-As Consultants with five or more on your left sales team and five or more on your right sales team.

**Q: What is a personally enrolled Paid-As Consultant?**

**A:** This is someone you have personally enrolled into Isagenix who has accumulated 100 personal volume through personal purchases or retail purchases through their replicated Isagenix website and also maintains a minimum of 100 BV from personally enrolled members on their left and right sales teams, all within the prior 30 days, as illustrated below:
