# FAQ

**Q: What is my Recognition Rank?**

**A:** Your Recognition Rank is the highest rank you've ever achieved with your Isagenix business. You can see your Recognition Rank on the left-side panel on the home page of your Back Office.

**Q: Where can I view how many Personally-Enrolled Paid-As Consultants I currently have?**

**A:** The Crystal Reset report shows how many Paid-As Consultants you currently have in your 1PET. This report will be available in your Back Office starting on 27 January.

**Q: Can I reactivate inactive Consultants in order to achieve Crystal Bonuses?**

**A:** If you are going for the Crystal Manager, Director or Executive bonus for the first time, you may use new Consultants and you may also reactivate Consultants you've had in the past. You just need to have the 2, 6 or 10 Paid-As Consultants by the Crystal Reset deadlines of 22 March, 17 May and 12 July respectively.

Executives looking to re-earn the bonuses must enrol and develop new Consultants to qualify.

**Q: What is my 1PET?**

**A:** The 1PET is the first level of your Personally-Enrolled team. Personally-Enrolled means you help someone open a membership account with Isagenix — as a Preferred Customer or Associate, they are considered your Personally-Enrolled Member and they are assigned a place on your Team Placement Tree — on either your Left Sales Team or your Right Sales Team.

**Q: If I earn a Crystal Reset bonus, when will I receive it?**

**A:** If you meet the requirements to earn a Crystal Reset bonus, you would receive your bonus payout the week after you've successfully done so.

**Q: I'm a current Executive, am I required to develop 5 Consultants on my left team and 5 Consultants on my right team to earn the Executive Bonus again?**
