## FREQUENTLY ASKED QUESTIONS

### What type of enrolments count towards the 'Ready. Set. Summer' promotion?

New Customers and Preferred Customers who enrol with an initial order of at least AU195 BV or NZ186 BV will count toward earning 'Ready. Set. Summer' cash bonuses. Enrolments are calculated cumulatively per month and bonuses are capped at US\$800 per month.

For example, if Max enrolls 18 new Customers in December and 6 new Customers in January, Max will qualify for US\$800 in December and US\$200 in January. And if Max has also bought an ANZ Celebration 2018 ticket and attends the event, he will also qualify for the US\$200 Celebration Bonus.

### Do new Customers in other countries count toward the 'Ready. Set. Summer' promotion?

Yes qualifying enrolments from other countries are counted towards the total as long as they meet the minimum 186BV requirement.

### When can I expect to receive my bonus?

Cash bonuses will be paid out in your commissions on 16 January 2018 for the December promotional period and 20 February 2018 for the January promotional period. Celebration Bonus qualifiers will be rewarded two weeks after ANZ Celebration 2018 concludes.

### Is Autoship required for the new Customers?

No, Autoship is not required for eligibility.

### How do I qualify for the Celebration Bonus?

You must enrol 12 new Customers in December and/or January, have purchased an ANZ Celebration 2018 event ticket in your Back Office and be checked into the event to qualify. Celebration Bonus qualifiers will be rewarded 2 weeks after ANZ Celebration 2018 concludes. The Celebration Bonus is capped at US\$200 per business per qualifying month.
