FAQS

Who can participate in this promotion?

This promotion is open to Consultants, Manager and Directors who reach the NEW Recognition Rank of Director or Executive for the first time. Members who have previously achieved the Recognition Rank of Director prior to 1 April 2018 23:59 US EST are not eligible for Director Bonus Cycles. Members who have previously achieved the Recognition Rank of Executive prior to 1 April 2018 23:59 US EST are not eligible for Executive Bonus Cycles.

Do I need to maintain my Active Rank every week during the 12week window to qualify for the bonus?

The 12-week window unlocks the week after you achieve the rank for the first time and expires 12 weeks later. Qualifying weeks do not need to be consecutive to receive the bonus. To qualify for any one week, you must maintain the Active Rank every day of that week. We are creating a new report to monitor this 12 week window.

Will I be eligible to receive the Director Double Cycles Bonus if I rank advance to Executive within my 12-week window?

If you rank advance to the NEW rank of Executive within your 12-week window you will no longer be eligible to receive the Director Bonus Cycles because you will be eligible for the Executive Bonus Cycles. A 12-week window unlocks the week after you achieve Executive and expires 12 weeks later.

Do cycle equivalents count towards my cycles?

How can I keep track of my progress?
